## FINAL FEE APPLICATION OF BLANCO TACKABERY COMBS & MATAMOROS, P.A. FOR COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES AS CO-COUNSEL TO THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF PREMIERE ASSOCIATES, INC. AND ITS SUBSIDIARIES FOR THE PERIOD FROM JANUARY 4, 2002 <u>THROUGH MAY 12, 2003</u>

By this application (the "Final Fee Application"), pursuant to 11 U.S.C. §§ 330 and 331 and Rule 2016 of the Federal Rules of Bankruptcy Procedure and the Order, Under §§ 105(a) and 331, Establishing Revised Procedures for Interim Compensation and Reimbursement of Expenses of Professionals dated February 22, 2001 (the "Interim Compensation Order"), the law firm of Blanco Tackabery Combs & Matamoros, P.A. ("BTCM") hereby seeks final approval of all interim fee applications filed by BTCM in these cases as co-counsel to the Official Committee of Unsecured Creditors of Premiere Associates, Inc. and its Subsidiaries (the "Premiere Committee"), in the total amount of \$347,686.87 for legal services rendered, together with reimbursement of actual and necessary expenses incurred in the amount of \$37,321.57, for the period January 4, 2002 through May 12, 2003 (the "Final Fee Period"). In support of this Final Fee Application, BTCM respectfully represents as follows:

1. This Court entered its order on February 14, 2002 appointing BTCM as cocounsel to the Premiere Committee *nunc pro tunc* to January 4, 2002, granting BTCM's application dated January 16, 2002 (the "Order"). The Order authorized BTCM to be compensated on an hourly basis and to be reimbursed for actual and necessary expenses.

#### **RELIEF REQUESTED**

2. All services for which compensation is requested by BTCM were performed for, or on behalf of, the Premiere Committee.

3. BTCM seeks final approval of all interim fee applications. BTCM has previously submitted interim fee applications for services rendered and reimbursement of expenses as follows:

a. for the period from January 4, 2002 through January 31, 2002 in the amount of \$46,423.25 for fees and \$785.10 for expenses;

b. for the period from February 1, 2002 through February 28, 2002 in the amount of \$20,064.50 for fees and \$1,254.31 for expenses;

c. for the period from March 1, 2002 through March 31, 2002 in the amount of \$37,788.75 for fees and \$4,858.07 for expenses;

d. for the period from April 1, 2002 through April 30, 2002 in the amount of
\$93,490.37 for fees and \$8,475.77 for expenses;

e. for the period from May 1, 2002 through May 31, 2002 in the amount of
\$6,158.00 for fees and \$3,433.42 for expenses;

f. for the period from June 1, 2002 through June 30, 2002 in the amount of \$7,414.00 for fees and \$24.66 for expenses;

g. for the period from July 1, 2002 through July 31, 2002 in the amount of\$6,884.00 for fees and \$3,988.08 for expenses;

h. for the period from August 1, 2002 through August 31, 2002 in the amount of \$3,412.00 for fees and \$32.95 for expenses;

i. for the period from September 1, 2002 through September 30, 2002 in the amount of \$6,764.00 for fees and \$180.91 for expenses;

j. for the period from October 1, 2002 through October 31, 2002 in the amount of \$5,231.00 for fees and \$163.87 for expenses;

k. for the period from November 1, 2002 through November 30, 2002 in the amount of \$2,247.50 for fees and \$11.09 for expenses;

1. for the period from December 1, 2002 through December 31, 2002 in the amount of \$23,328.00 for fees and \$840.75 for expenses;

m. for the period from January 1, 2003 through January 31, 2003 in the amount of \$27,856.50 for fees and \$1,993.45 for expenses;

n. for the period from February 1, 2003 through February 28, 2003 in the amount of \$30,227.25 for fees and \$4,340.48 for expenses;

o. for the period from March 1, 2003 through March 31, 2003 in the amount of \$15,718.75 for fees and \$4,628.24 for expenses;

p. for the period from April 1, 2003 through April 30, 2003 in the amount of
\$8,871.00 for fees and \$702.40 for expenses; and

q. for the period from May 1, 2003 through May 12, 2003 in the amount of\$5,808.00 for fees and \$1,608.02 for expenses.

4. Except for the interim fee applications for the periods March 1, 2003 through May 12, 2003, which are to be heard on October 14, 2003, the Court has previously approved all interim fee applications submitted by BTCM.

5. BTCM requests final approval of all interim fee applications filed by BTCM in these cases, in the total amount of \$347,686.87 for legal services rendered, together with reimbursement for actual and necessary expenses incurred in the amount of \$37,321.57. A summary of the hours and fees of each professional, a summary of compensation by project category, and an expense summary for the Final Fee Period are attached hereto as Exhibit A.

6. Given the nature and value of the services provided by BTCM to the Premiere Committee as described herein, the amounts sought under this Final Fee Application are fair and reasonable under Section 330 of the Bankruptcy Code.

7. BTCM has received no payment and no promises for payment from any source for services rendered to the Premiere Committee in connection with these cases. There is no agreement or understanding between BTCM and any other person, other than members of the firm, for the sharing of compensation to be received for the services rendered in these cases.

#### **SUMMARY OF SERVICES RENDERED**

8. BTCM has advised the Premiere Committee on a regular basis with respect to legal matters in connection with those certain "Avoidance Actions" and "Directors and Officers Actions" referred to in the Order, and in connection with the Debtor's plan of reorganization. Furthermore, BTCM has: (1) prepared and/or assisted in the preparation of various motions, applications, orders, and other pleadings submitted to the Court for consideration; (2) appeared in court to present necessary motions, applications, objections, and pleadings and otherwise represented the interests of the Premiere Committee to the extent such pleadings pertain to the Premiere Group Debtors; (3) engaged in meetings, negotiations, discussions, and communications with interested parties; and (4) performed all necessary professional services

which were described and narrated in detail in the previously filed interim fee application exhibits.

9. BTCM has been involved in all substantive matters involving the estate and the Premiere Committee.

#### **AMOUNTS REQUESTED**

10. BTCM seeks compensation in the amount of \$347,686.87 for the Final Fee Period in connection with the professional services described hereinabove.

11. BTCM incurred certain disbursements during the Final Fee Period in the total amount of \$37,321.57. This disbursement sum is broken down into categories of charges, which may include, among other things, telephone and telecopier charges, toll charges, mail and express mail charges, special or hand delivery charges, filing fees, recordation fees, photocopying charges, deposition services and transcript costs, travel expenses, expenses for working meals, and Pacer research charges. BTCM does not charge separately for document processing or non-ordinary overhead expenses such as overtime for secretarial personnel and other staff. A complete review by category of the expenses incurred for the Final Fee Period and an itemization of expenses within each expense category, as required by Del. Bankr. LR 2016-2(e)(ii), may be found in the previously filed interim fee application exhibits.

12. Costs incurred for computer assisted research, if any, are not included in BTCM's normal hourly billing rates and, therefore, are itemized and included in BTCM's disbursements. Pursuant to Del. Bankr. LR 2016-2, BTCM represents that its rate for duplication is \$0.15 per page, and its rate for outgoing telecopier transmissions is \$1.00 per page (excluding related long distance transmission charges). There is no charge for incoming telecopier transmissions and there is no surcharge for computerized research, if any.

13. In accordance with the factors enumerated in 11 U.S.C. § 330, the amounts requested for compensation and expense reimbursement are fair and reasonable given: (a) the complexity of these cases; (b) the aggressive opposition by Debtors and the IHS Committee to the efforts of the Premiere Committee; (c) the complexity of the issues involved in representing the Premiere Committee in the matters of representation; (d) the time expended; (e) the nature and extent of the services rendered; (f) the value of such services; and (g) the costs of comparable services other than in a case under this title.

14. BTCM believes that the time entries and expense entries included in the exhibits to the previously filed interim fee applications are in compliance with the requirements of Del. Bankr. LR 2016-2.

15. BTCM has sent a copy of this Final Fee Application to the Office of the United States Trustee and all parties in interest that have requested notice pursuant to Rule 2002 of the Federal Rules of Bankruptcy Procedure. In light of the relief requested herein, BTCM submits that no further notice of the Final Fee Application is necessary.

WHEREFORE, BTCM respectfully requests final approval of all BTCM interim fee applications in these cases, in the total amount of \$347,686.87 for professional services rendered to the Premiere Committee for the Final Fee Period and \$37,321.57 for reimbursement of actual and necessary costs and expenses incurred during the Final Fee Period.
