J.P. Morgan Trust Company, National Association ("Applicant"), formerly known as Chase Manhattan Trust Company, National Association (as successor trustee to PNC Bank, Kentucky, Inc.) as Convertible Subordinated Debenture Trustee for the 5 1/2% Convertible Subordinated Debentures due 2003 of Rotech Medical Corporation in the original principal amount of \$126,500,000.00 ("Convertible Subordinated Debenture Trustee") pursuant to Section 2.5 of the Second Amended Joint Plan of Rotech Medical Corporation and Its Subsidiaries under Chapter 11 of the Bankruptcy Code ("Rotech Plan") applies to the Court for the allowance and payment for the reimbursement of expenses paid by the Convertible Subordinated Debenture Trustee for professional fees and expenses and for trustee administrative expenses ("Application"). In support of its Application, Applicant respectfully represents as follows:

### I. BASIS FOR APPLICATION

1. This Court on February 22, 2002, entered an Order confirming the Rotech Plan. This Application is made pursuant to Section 2.5 of the Rotech Plan. Section 2.5 provides the "Convertible

Subordinated Debenture Trustee shall file a first and final application for allowance of compensation for services rendered and to be rendered, and for reimbursement of expenses incurred and to be incurred."

### II. BACKGROUND

- 2. On February 2, 2000 (the "Filing Date"), each of the above-captioned debtors and debtors in possession (the "Debtors") filed a voluntary petition for relief under Chapter 11 of the United States Code (the "Bankruptcy Code") with the United States Bankruptcy Court for the District of Delaware. The Debtors' Chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to an Order of this Court.
- 3. On March 3, 2000, Allison J. Maggiolo and Mark A. Robinson of the firm Wyatt, Tarrant & Combs, LLP entered an appearance as counsel for Chase Manhattan Trust Company (now J.P. Morgan Trust Company), Indenture Trustee for the 5 1/4% Convertible Subordinated Debentures due 2003 of Rotech Medical Corporation ("Rotech").
- 4. On May 10, 2000, William P. Bowden and Christopher S. Sontchi of the firm Ashby & Geddes, P.A. entered an amended notice of appearance for Chase Manhattan Trust Company (now J.P. Morgan Trust Company), Indenture Trustee for the 5 1/4% Convertible Subordinated Debentures due 2003 of Rotech.
  - 5. On February 22, 2002, the Court entered an Order Confirming The Rotech Plan.
- 6. Pursuant to Section 2.5 of the Rotech Plan, the Applicant, as Convertible Subordinated Debenture Trustee is allowed to file a first and final application for fees and expenses to be paid only from any distribution to Class 6 under the Rotech Plan.

### III. RELIEF REQUESTED

- 7. This Application is the first and final fee application filed by Applicant in this case. As reimbursement for fees and expenses previously incurred and paid to Wyatt, Tarrant & Combs, LLP, and Ashby & Geddes, P.A. (collectively, "Law Firms") and for fees and expenses to be incurred and paid to the Law Firms in connection with the professional services described below, by this Application, Applicant seeks reimbursement compensation in the amount of \$71,470.50 and expense reimbursement in the amount of \$4,195.88 for the period from February 2, 2000 to May 10, 2002 (45 days after the Effective Date) ("Application Period"). The \$71,470.50 Applicant seeks in legal fees is comprised of \$67,470.50 for reimbursement of legal services previously rendered and paid and \$4,000.00 to be rendered prior to May 10, 2002.
- 8. By this Application, Applicant also seeks payment of administrative expenses it incurred and will incur in the amount of \$13,750.00 for the Application Period.
- 9. In accordance with Local Rule 2016.2, attached hereto as Exhibit A are tables which set forth (1) the name of each attorney rendering services, the attorney's hourly billing rate, total billed hours by each attorney and total compensation requested by each attorney; (2) compensation requested segregated by project category; and (3) an expense summary.
- 10. In accordance with Local Rule 2016.2, attached hereto as Exhibit B is a copy of the itemized invoices of the Law Firms listing the hours spent in representation of the Class 6 members, the dates upon which such services were rendered, the name and initials of the attorney or paralegal rendering such services and a description of all services rendered.
- 11. In general, the services rendered by the Law Firms as counsel to the Applicant included, without limitation, the following project categories:
  - A. Case Administration;

- B. Bondholder Communications;
- C. Litigation;
- D. Claims Administration;
- E. Business Operations;
- F. Plan and Disclosure Statement:
- G. Upstream Guaranty Issues; and
- H. Fee Application.
- 12. Specific descriptions of the services rendered by the Law Firms for the Applicant, grouped according to project category, are provided below:
  - A. <u>Case Administration</u>. Law Firms rendered a total of 142.30 hours and \$33,098.00 in services in the category of "Case Administration" during the Application Period. This category includes time spent reviewing the bankruptcy pleadings, and related documents, strategy development, and communications with the Convertible Subordinated Debenture Trustee.
  - B. Bondholder Communications. Law Firms rendered a total of 53.30 hours and \$10,956.00 in services in the category of "Bondholder Communications" during the Application Period. The category includes time spent communicating with and advising the convertible subordinated debenture holders ("Holders") regarding the bankruptcy proceedings, including written notices to such Holders.
  - C. <u>Litigation</u>. Law Firms rendered a total of 46.60 hours and \$10,247.50 in services in the category of "Litigation" during the Application Period. This category

- includes time spent on obtaining documents relating to Rotech's guaranty, drafting the Rule 2004 motion, and negotiating with opposing counsel.
- D. Claims Administration. Law Firms rendered a total of 26.90 hours and \$6,679.50 in services in the category of "Claims Administration" during the Application Period. The category includes time spent drafting a proof of claim for the Holders, Rule 2019 Statement of Indenture Trustee and communicating with the Holders regarding the proof of claim.
- E. <u>Business Operations</u>. Law Firms rendered a total of 6.30 hours and \$1,431.50 in services in the category of "Business Operations" during the Application Period.

  The category includes time spent researching the financials of the Debtors and analysis of the motions regarding financial arrangements with former officers of Rotech.
- F. Plan and Disclosure Statement. Law Firms rendered a total of 2.30 hours and \$672.50 in services in the category of "Plan and Disclosure Statement" during the Application Period. This category includes time spent analyzing Disclosure and Plan documents approved by the Court.
- G. <u>Upstream Guaranty Issues</u>. Law Firms rendered a total of 7.10 hours and \$1,725.50 in services in the category of "Upstream Guaranty Issues" during the Application Period. This category includes time spent researching, relating to assessing the validity of an upstream guaranty from Rotech to Integrated Health Systems.

- H. Fee Application. Law Firms rendered a total of 26.60 hours and \$2,660.00 in services in the category of "Fee Application" during the Application Period. This category includes time spent drafting and revising the Application along with organization of information for inclusion in the Application.
- 13. All services for which compensation is requested hereunder were performed or will be performed by the Law Firms in representation of the Applicant or by the Applicant in maintaining and administering the Rotech account as Convertible Subordinated Debenture Trustee with such payment of allowed fees and expenses to be paid only from any distribution to Class 6 as authorized by Section 2.5 of the Rotech Plan.
- services at the lowest possible cost. Whenever possible, rather than "recreating the wheel," the Law Firms have called upon the considerable expertise of their senior partners to obtain quick answers to difficult questions without the need for expensive and time consuming legal research. Where research has been required, the Law Firms have utilized the low billing rates of junior associate lawyers, resulting in overall savings. In addition, the Law Firms divided responsibilities among themselves in an effort to keep intra-firm meetings and duplication of effort to an absolute minimum. The Law Firms respectfully submit that they have been efficient in avoiding duplication of effort and keeping fees and costs at the lowest level possible.
- 15. The Law Firms do not build a profit component into their disbursements and charges only the Law Firms' actual out-of-pocket expenses. Photocopy charges are billed at \$.12 per page. Outgoing faxes are billed at \$1.00 per page. No fee is charged for incoming faxes. The Law Firms have made extensive use of e-mail to significantly reduce such charges.

- In accordance with the factors enumerated in 11 U.S.C. §330, the amounts requested for compensation and expense reimbursement are fair and reasonable given (a) the complexity of the case; (b) the time expended; (c) the nature and extent of the services rendered; (d) the value of such services; and (e) the costs of comparable services other than in a case under this title.
- 17. Applicant certifies that no agreement or understanding has existed or does exist between Applicant and any other person for the sharing of compensation received or to be received by and in connection with the services rendered in this case.
- 18. Capitalized terms used in this Application unless specifically defined herein shall have the meanings ascribed to such terms in the Rotech Plan.
- 19. Applicant has sent a copy of this Application to the parties named on the attached service list.

WHEREFORE, Applicant prays that allowance be made to it for the Application Period in the sum of \$67,470.50 for reimbursement of sums paid for professional services, with an additional \$4,000.00 for professional services to be rendered until the end of the Application Period, and the sum of \$4,195.88 for reimbursement of actual and necessary costs and expenses paid to the Law Firms, and the sum of \$13,750.00 for payment of administrative fees and expenses during the Application Period, (for total compensation in the amount of \$85,220.50 and total expense reimbursement of \$4,195.88) and that the

Debtors be authorized and directed to pay Applicant such allowed amounts as set forth in Section 2.5 of the Rotech Plan with such payment from any distribution to Class 6 under the Rotech Plan.





# ORDER GRANTING FIRST AND FINAL FEE APPLICATION IN THE ROTECH DEBTORS CASES

FOR J.P. The Court having considered the Application of J.P. Morgan Trust Company, National Association, formerly known as Chase Manhattan Trust Company, National Association (as successor trustee to PNC Bank, Kentucky, Inc.) for compensation and reimbursement of expenses for the period February 2, 2000 through May 10, 2002 (45 days after the Effective Date) (the "Application"), which requests final allowance and approval of compensation and reimbursement of expenses in accordance with Section 2.5 of the Second Amended Joint Plan of Reorganization ("Rotech Plan") and it appearing that notice of the Application was duly given in accordance with the provisions of the Bankruptcy Rules, and no further notice being necessary, and after due deliberation, and sufficient cause appearing therefore, it is hereby;
