ADMINISTRATIVE ORDER PURSUANT TO 11 U.S.C. §§ 105(a) AND 331 ESTABLISHING PROCEDURES FOR INTERIM COMPENSATION AND REIMBURSEMENT OF EXPENSES OF PROFESSIONALS

Upon the motion dated January 22, 2002 (the "Motion"), wherein Kmart Corporation ("Kmart") and 37 of its domestic subsidiaries and affiliates, debtors and debtors-in-possession in the above-captioned cases (collectively, the "Debtors"), moved this Court for entry of an order, pursuant to sections 105(a) and 331 of the Bankruptcy Code, establishing procedures for interim compensation and reimbursement of expenses of professionals specifically retained by order of this Court; it appearing to the Court that (i) It has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (iii) the relief requested in the Motion is in the best interests of the Debtors, their estates and their creditors; (iv) proper and adequate notice of the Motion and the hearing thereon has been given and that no other or

further notice is necessary; (v) upon the record herein after due deliberation thereon, that the relief should be granted as set forth below,

- 1. Except as may otherwise be provided in Court orders authorizing the retention of specific professionals, all professionals in these cases may seek interim compensation in accordance with the following procedure:
- a. On or before the last day of each month following the month for which compensation is sought (the "Monthly Statement Date"), each professional will submit a monthly statement to: (i) the Debtors at Kmart Corporation, 3100 West Big Beaver Road, Troy, MI 48084-3163 (Attn: Janet Kelley, Senior Vice President & General Counsel); (ii) counsel to the Debtors, Skadden, Arps, Slate, Meagher & Flom (Illinois), 333 West Wacker Drive, Suite 2100, Chicago, Illinois 60606 (Attn: John Wm. Butler, Jr.); (iii) counsel to the administrative agents for Debtors' postpetition lenders, Morgan Lewis & Bockius, 101 Park Avenuc, New York, New York 10178 (Attn: Robert II. Scheibe and Jay Teitelbaum) and Katton Muchin Zavis, 525 West Monroe Street, Suite 1600, Chicago, Illinois 60661 (Attn: Joff Marwil and Brian Swott); (iv) counsel to any official committee appointed in these cases (who shall serve a notice of appearance on the Master Service List promptly after its retention); and (v) the United States Trustee, U.S. Trustee, Region 11,

60606. Each such person receiving such a statement will have twenty (20) days after the Monthly Statement Date to review the statement.

- b. At the expiration of the twenty (20) day period, the Debtors shall promptly pay ninety percent (90%) of the fees and one hundred percent (100%) of the disbursements identified in each monthly statement, except such fees or disbursements as to which an objection has been served as provided in paragraph (c) below. Any professional who fails to submit a monthly statement shall be ineligible to receive further payment of fees and expenses as provided herein until such time as the monthly statement is submitted. The first statements shall be submitted and served by each of the professionals by March 29, 2002 and shall cover the period from the commencement of this case through February 28, 2002;
- the Debtors' postpetition lenders or the Committee has an objection to the compensation or reimbursement sought in a particular statement, such party shall, within
 twenty (20) days of the Monthly Statement Date, serve upon the respective professional and the other persons designated to receive monthly statements, a written
 "Notice of Objection to Fee Statement" setting forth the precise nature of the
 objection and the amount at issue. Thereafter, the objecting party and the Professional whose statement is objected to shall attempt to reach an agreement regarding
 the correct payment to be made. If the parties are unable to reach an agreement on the

objection within twenty (20) days after receipt of such objection, the objecting party may file its objection with the Court and serve such objection on the respective professional and the other parties designated to receive monthly statements parties listed above and the Court shall consider and dispose of the objection at the next interim fee application hearing. The Debtors will be required to pay promptly those fees and disbursements that are not the subject of a Notice of Objection to Fee Statement.

- d. Approximately every four (4) months, each of the Professionals . shall file with the Court and serve on the parties designated to receive monthly statements, on or before the 45th day following the last day of the compensation period for which compensation is sought, an application for interim Court approval and allowance, pursuant to section 331 of the Bankruptcy Code, of the compensation and reimbursement of expenses requested for the prior four (4) months. The first such application shall be filed on or before June 17, 2002 and shall cover the period from the commencement of these cases through April 30, 2002. Any professional who fails to file an application when due shall be ineligible to receive further interim payments of fees or expenses as provided herein until such time as the application is submitted.
- e. The pendency of an application or a court order for payment of compensation or reimbursement of expenses, and the pendency of any Notice of

Objection to Fee Statement or other objection, shall not disqualify a Professional from the future payment or compensation or reimbursement of expenses as set forth above. Neither the payment of, nor the failure to pay, in whole or in part, monthly interim compensation and reimbursement as provided herein shall bind any party-in-interest or this Court with respect to the allowance of applications for compensation and reimbursement of Professionals.

f. Each member of the Committee In this case shall be permitted to submit statements of expenses and supporting vouchers to counsel for the Committee who shall collect and submit such requests for reimbursement in accordance with the foregoing procedure for monthly and interim compensation and reimbursement of Professionals.

ORDER PURSUANT TO 11 U.S.C. § 363(b) APPROVING
POST-PETITION AGREEMENT TO UTILIZE ESTATE FUNDS
FOR PAYMENT OF FEES AND EXPENSES INCURRED BY SPECIAL
COUNSEL TO THE INDEPENDENT DIRECTORS GROUP

Upon the motion dated August 9, 2002 (the "Motion") of Kmart Corporation ("Kmart") and certain of its affiliates, each a debtor and debtor-in-possession in the above-captioned cases (collectively, the "Debtors"), for entry of an order, pursuant to Section 363(b) of Title 11 of the United States Code, 11 U.S.C. §§ 101, et seq. (the "Bankruptcy Code"), approving the Debtors' agreement, as described in this Order, to use estate funds outside the ordinary course of business to pay Dewey Ballantine LLP ("Dewey Ballantine") for services rendered to the independent members of Kmart's Board of Directors (the "Independent Directors Group") as their special counsel ("Special Counsel"); and due and adequate notice of the Motion having been given; and it appearing that no other notice need be given; and it appearing that Dewey Ballantine neither holds nor represents any interest adverse to the Debtors' estates

with respect to the matters for which Dewey Ballantine is to be paid as described in this Order; and it appearing that the Official Financial Institutions' Committee (the "FIC"), the Official Unsecured Creditors' Committee (the "UCC"), and the Official Committee of Equity Security Holders (the "Equity Committee" and, together with the FIC and the UCC, the "Committees") consent to entry of this order; and it appearing that the relief requested in the Motion is in the best interest of the estates and their creditors, and after due deliberation thereon, that the relief should be granted as set forth below,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT

- 1. Pursuant to Section 363(b) of the Bankruptcy Code, and subject to the terms contained herein, the Debtors, as debtors-in-possession, are authorized to utilize estate funds to pay Dewey Ballantine from and after the petition date as Special Counsel to represent the Independent Directors Group in connection with these Chapter 11 cases and, more specifically, the performance of only the following legal services.
 - (a) review developments in these Chapter 11 cases and advise the Independent Directors Group in connection with these Chapter 11 cases;
 - (b) provide legal advice to the Independent Directors Group in support of the Independent Directors Group's ongoing responsibilities with respect to the Debtors' operations, including attendance at meetings of the Kmart Board of Directors, its committees and other third parties;
 - (c) represent the individuals comprising the Independent Directors Group in connection with specific matters involving the stewardship investigation, the Securities and Exchange Commission and the Department of Justice

(including through the U.S. Attorney's Office for the Eastern District of Michigan);

- (d) appear before the Bankruptcy Court, any district or appellate courts, and the United States Trustee on behalf of the Independent Directors Group with respect to the matters referred to above; and
- (c) provide the full range of legal services and advice normally associated with the matters referred to above.
- 2. All compensation and reimbursement of expenses to be paid to Dewey
 Ballantine shall be subject to the protocols of the Joint Fee Review Committee,
 including the rights of the Committees to review budgets proposed by Dewey
 Ballantine; to object to such budgets; and to object, in accordance with such protocols, to payment of requested amounts to Dewey Ballantine.
- 3. Dewey Ballantine shall be paid from the estates for post-petition services rendered to the Independent Directors Group; <u>provided</u>, <u>however</u>, that Dewey Ballantine shall not be paid from the estates an amount in excess of \$750,000 (including amounts already incurred) unless the Committees consent in writing or, absent such consent, the Court enters an order permitting such further payment. If such consent is not obtained, Dewey Ballantine may immediately withdraw from its representation of the Independent Directors Group with respect to the matter described in paragraph 1 hereof.
- Notwithstanding anything in this Order to the contrary, this Order does not authorize the Debtors to pay Dewey Ballantine for any fees or expenses incurred in

connection with providing legal services to any members of the Independent Directors Group to the extent that such legal services are rendered (i) in connection with claims made or actions asserted by or on behalf of the Debtors or the Committees or (ii) in connection with matters in which such members hold an interest adverse to the Debtors. For purposes of this paragraph, the Debtors shall be solely responsible for determining, in the first instance and in their reasonable discretion, whether an adverse interest exists; provided, however, that nothing herein shall be deemed to impair the ability of this Court or the right of the U.S. Trustee to consider at any time whether an adverse interest exists. The existence of the stewardship investigation referenced in paragraph 1(c) of this Order shall not, in and of itself, constitute or be decimed to create an adverse interest. In the event an adverse interest is determined to exist, the Independent Directors Group and Dewey Ballantine shall be promptly notified in writing of such determination. Subject to the limitations set forth in this Order, the Debtors shall be entitled to pay Dewey Ballantine from the Debtort' estates for services rendered to the Independent Directors Group up to the date of their. receipt of such notice.

5. This Order does not address and does not affect the ability of any individual member of the Independent Directors Group to retain Dewey Ballantine to represent him or her individually, and is without prejudice to the rights of the Independent

Directors Group or Dewey Ballantine to request payment of administrative expenses

from the Debtors' estates in accordance with applicable law.
