APPLICATION OF THE OFFICIAL COMMITTEE  
OF UNSECURED CREDITORS FOR APPROVAL OF  
REIMBURSEMENT OF COMMITTEE MEMBER EXPENSES

TO: THE HONORABLE SUE L. ROBINSON,  
UNITED STATES DISTRICT JUDGE:

The application of the Official Committee of Unsecured Creditors (the  
“Committee”) of Purina Mills, Inc. and its affiliated debtors and debtors-in-possession (the  
“Debtors”), by its attorneys, Akin, Gump, Strauss, Hauer & Feld, L.L.P. (“Akin Gump”),  
seeking approval of reimbursement of expenses incurred by certain Committee members (the  
“Application”), respectfully represents:

1. On October 28, 1999, the Debtors filed voluntary petitions under chapter  
11 of Title 11 of the United States Code (the “Bankruptcy Code”), and were thereupon continued  
in the management and operation of their businesses and properties pursuant to §§ 1107 and  
1108 of the Bankruptcy Code.

2. On November 9, 1999 (the "Appointment Date"), the United States Trustee for the District of Delaware appointed the Committee which currently consists of six members. The following entities constitute the current members of the Committee:

1. Bank One Trust, Co.;
2. Greenwich Street Capital Partners, Inc;
3. Franklin Resources;
4. William E. Simon & Sons;
5. Kornitzer Capital Management, Inc.;
6. PSC Sales (USA) Inc.; and
7. Tyson Foods, Inc.

3. The Application seeks approval of the reimbursement for expenses incurred by Greenwich Street Capital Partners, Inc ("Greenwich"), a member of the Committee, in the aggregate amount of \$2,833.75. The Application is submitted in accordance with §§ 105 and 503(b) of the Bankruptcy Code, Rule 2016 of the Federal Rules of Bankruptcy Procedure and the administrative order entered by this Court on October 29, 1999 establishing procedures for the submission of interim applications by professionals in these cases for compensation and reimbursement of expenses (the "Administrative Fee Order").

4. Greenwich has submitted a request for the out-of-pocket expenses incurred in connection with Committee meetings held in Wilmington, Delaware and St. Louis, Missouri. Documentation of the out-of-pocket expenses is attached hereto as Exhibit "A" to this Application.

5. The expenses that are the subject of the Application were the actual and necessary expenses incurred by Greenwich in the discharge of its duties as a Committee member.

6. Greenwich, the Chairman of the Committee, also seeks reimbursement of the fees and expenses of its counsel, Weil, Gotshal & Manges LLP ("Weil Gotshal"), in accordance with Section 503(b) of the Bankruptcy Code. Greenwich incurred legal fees in the

amount of \$43,623.00 and related expenses in the amount of \$1,736.48 in connection with the performance of its duties as a member of the Committee. Documentation regarding Weil Gotshal's fees and expenses are attached as Exhibits "B" and "C" to this Application. These costs were actual and necessary expenses incurred by Greenwich in the discharge of its duties as a member of the Committee.

7. As set forth in First Merchants Acceptance Corporation v. C. Bradford & Co., 198 F.3d 394 (3d Cir. 1999), a member of a creditors committee may be reimbursed for attorney's fees if they were actual and necessary expenses incurred by a member of the creditors committee in the performance of its duties. Greenwich, as Chairman of the Committee, was required to spend a great deal of time negotiating on the Committee's behalf on certain key issues in the Chapter 11 cases. Specifically, Greenwich and Weil Gotshal were involved in the negotiations regarding (a) an acceptable settlement concerning the proposed debtor-in-possession financing, (b) a modified key employee retention plan ("KERP") for the Debtors, (c) resolution of certain open issues regarding the settlement reached with Koch Industries, Inc., (d) acceptable terms for exit financing and (e) the formulation of a consensual plan of reorganization for the Debtors. Weil's legal fees and expenses relating to these matters are actual and necessary expenses incurred by Greenwich in the performance of its duties as the Chairman of the Committee. Accordingly, Greenwich seeks reimbursement for such costs.

8. No prior application has been made for the approval of reimbursement of expenses for the Application Period listed herein.

**WHEREFORE**, the Committee requests an order (i) approving the reimbursement to Greenwich Street Capital Partners, Inc. for its actual, necessary expenses in the amount set forth in Exhibit "A" attached hereto; (ii) approving the reimbursement of the fees and

expenses of its counsel, Weil, Gotshal & Manges LLP; and (iii) granting such other and further relief as the Court deems just and proper.
